The light source is an LED customised and dimmable plate, which can be regulated through a three-phase dimmer switch on the base in the table version.*

**MANUTENZIONE E PULIZIA****STRUTTURA**

Utilizzare un panno asciutto per pulire la struttura della lampada.

**FRANGE**

Le frange del modello Arcipelago sono lavabili. Conservare il sacchetto per il lavaggio. Immergere, dentro il sacchetto, le frange in acqua a 30° e detersivo. Sciacquare sotto acqua corrente. Appendere ancora bagnato. Nel caso le frange si accorcino dopo il lavaggio, stirare con ferro tiepido (temperatura per seta).

**MAINTENANCE AND CLEANING****FRAME**

Use a dry cloth to clean the frame of the lamp.

**FRINGES**

The fringes of the model Arcipelago are washable. Keep the bag for washing. Immerse the fringes inside the bag in water and clean it at the temperature of 30°C. Rinse with flowing water. Hang while still wet. In case the fringes get shorter after washing, iron with warm iron (use the temperature for silk).
